EMERGENCY PROCEDURES



- a power driven vessel up to and including 4.8m in length • a personal watercraft (PWC) • an off-the-beach sailing yacht, pedal boat and fun boat
- a canoe, kayak, rowing boat a recreational tender
- which is underway, you must wear a lifejacket **AT ALL TIMES.**

IF YOU ARE IN AN OPEN AREA OF:

 a yacht (including monohull, trailerable and multihull yachts, excluding off-the-beach sailing yachts) • a power driven vessel greater than 4.8m and less than 12m which is underway, a lifejacket must be worn AT TIMES OF 'HEIGHTENED RISK'.

WHAT TYPE OF LIFEJACKET MUST I WEAR?



'HEIGHTENED RISK' MEANS WHEN:

- crossing an ocean bar
- boating alone
- operating at night or in restricted visibility
- operating in an area where a gale, storm or severe thunderstorm warning
- or severe weather warning issue by the Bureau of Meteorology is current the vessel is a yacht and safety barriers or safety harnesses are not in use
- the vessel may capsize or be swamped or when occupants are at risk of falling overboard
- the vessel is disabled.
