Board Appointments

This was the last meeting of the current Board of Goulburn-Murray Water.

The deputy chairperson, John Pettigrew and director Jean Sutherland retired as of 30 September. The chairperson, Don Cummins, also completed his term of appointment at the same time.

Stephen Mills has been appointed as the new chairperson of Goulburn-Murray Water. with Claire Penniceard and Catherine Scott appointed as directors to replace John Pettigrew and Jean Sutherland.

Water Resource Issues

A presentation was made to the Board on the resource position, current allocations and the outlook for the remainder of the irrigation season. The Board noted with concern the extremely poor and deteriorating resource position and the likelihood of very low allocations persisting.

Goulburn-Murray Water will continue to ensure that it maintains contact with its customers, with businesses and with the wider community during these difficult times, helping G-MW to receive feedback and to discuss the way ahead with the wider customer, business and community base.

Automation of Trunks and Carriers

A presentation was made to the Board on automation and modernisation across the entire system, the presentation being made from experiences gained from the CG1234

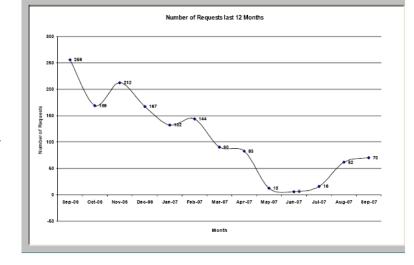

Central Goulburn 1234 Channel and Shepparton Modernisation Projects

The Board approved the final stage of the CG1234 Channel System Modernisation Project and the Shepparton Modernisation Project, subject to finalisation of funding arrangements.

Channel Automation Performance

The number of channel automation maintenance requests has declined steadily over the past 12 months as shown in the graph, notwithstanding a 15% increase in the number of automated sites across G-MW's region in that time.



Water Share Transactions

A backlog of work has occurred with water share

transactions where the numbers (generally in the vicinity of 200-300 per annum) have increased to some 700 received in the first three months of this financial year. The issues relating to the build-up, in particular those relating to Water Register access, were discussed, along with actions being taken to address the matter.
