

# Waterway Determination and Catchment Assessment

### What is this application form for?

Use this form to apply to Goulburn-Murray Water to make a determination as to whether the land on which you propose to construct or alter a dam is on a waterway. This application also includes provision for Goulburn-Murray Water to determine the catchment yield of the land. This determination is required under section 51 and section 67 *Water Act* 1989 (Vic).

### What to do:

- Read the accompanying explanatory notes and refer to the current fee schedule (which can be obtained by calling 1800 013 357 or downloaded from <u>www.g-mwater.com.au</u>) before you fill out the form.
- Complete the form in full ensuring all relevant information is provided.
- Complete the checklist. Incorrect information may result in your application being refused. Your application will be returned if it is ineligible or incomplete.
