What is this application form used for?

This application form should be used when you:

- Require a Letter of Consent from GMW when registering a transfer of land or plan of subdivision, or are refinancing and there is a GMW Caveat, Lease or Notice of Intention to Acquire on your certificate of title.
- Have a Caveat on your certificate of title which you believe needs to be removed due to completion of the relevant works or charge.
- Have an easement on your title plan that you believe may be in favour of GMW or its predecessor and you may want to build or develop on that easement. **NOTE: DO NOT USE THIS FORM TO MAKE PRE-PLANNING PERMIT APPLICATIONS.
