

Strathbogie Groundwater Management Area

The Strathbogie Groundwater Management Area (GMA) extends from the ridgeline of the Strathbogie Ranges in the south and east, borders with the Mid Goulburn GMA in the west and includes the townships of Euroa and Violet Town (shown on map overleaf).

Groundwater resources are managed through the Strathbogie GMA Local Management Plan.

Groundwater resources

Groundwater level and rainfall charts are provided overleaf.

Groundwater levels in the Shepparton Formation aquifer near Euroa have remained stable since the early-1990s.

In the south of the GMA, groundwater levels in the Bedrock aquifer are close to the ground surface, and have been slowly declining over the same timeframe.

Groundwater licensed volume and use

There is currently 1,422.0 megalitres per year (ML/yr) of groundwater licensed volume in the Strathbogie GMA (Table 1).




Figure 1 Annual metered use as a proportion of licensed volume in the Strathbogie GMA

Metered use in the Strathbogie GMA in 2016/17 was 467.6 ML which is 33% of total licensed volume. This was slightly less than in 2015/16 (Figure 1); likely influenced by above-average rainfall received in the Strathbogie GMA in 2016/17.

Total licensed volume decreased slightly in 2016/17 due to the cancellation of two licences, totalling 41.0 ML/yr.

Groundwater trading

Licence holders may transfer licensed volume on a temporary or permanent basis, within or between management zones, provided zone limits (listed in Table 1) are not exceeded.

In 2016/17 one temporary transfer was undertaken; 11 ML/yr was transferred from the Seven Zone to a licensed bore located in the Broken GMA. No transfers have been undertaken previously in the Strathbogie GMA.





Transferring licensed volume can provide an opportunity to generate income from unused water for sellers, or increase production for buyers.


