BOATS REQUIRING A LICENCE

1. All boats up to 9.1 metres (30 feet) in length containing a toilet and/or sleeping accommodation*;
 - 1.1 If the boat contains a marine toilet which discharges directly into the water it must be rendered inoperable;
 - 1.2 The boat must have aboard a portable toilet fitted with mechanical seals to prevent spillage.

(*NOTE: The boat is deemed to contain sleeping accommodation if it has bunks or benches in excess of 1.5 metres (5 feet) in length which could be slept on. Boats with sleeping accommodation must also have on-board a portable toilet. If a boat contains a toilet and/or sleeping accommodation it must be licenced to operate on Lake Eildon by GMW, irrespective of any intention by the owner/s and/or any passengers or guests to sleep overnight on the vessel).
