### **Re: Mitiamo Pipeline Tank Rebate Scheme**

I am pleased to share that the Mitiamo Pipeline Project has established a Tank Rebate Scheme to assist Landowners with the purchase of water tanks required to connect to the new pipeline. The scheme is designed to assist landowners who are prepared to connect to the new pipeline ahead of the spring 2021 Irrigation Season.

Goulburn-Murray Water, via the Mitiamo Pipeline Project Team, will provide Mitiamo Pipeline customers a rebate of up to **\$1,500 (excl GST) for the purchase cost of one tank per tapping point.** If the purchase cost of the tank (excluding delivery and installation) is less than \$1,500 (ex GST), then the rebate will be limited to the purchase cost of the tank (excluding delivery and installation).

Landowners are required to submit their claims including proof of purchase by **30 April 2021**. Landowners are required to submit proof the tank has been installed by **31 June 2021**. Landowners with more than one tapping point connected to the Mitiamo Pipeline can claim a rebate at each tapping point where a tank has been installed compliant with the above timeframes.

Landowners are to arrange their own purchase, delivery and installation of tanks. There is no preferred tank supplier/manufacturer for eligibility in the Tank Rebate Scheme.

The following documents are attached:

- Conditions and Guidelines applicable to the Tank Rebate Scheme. Please ensure that you comply with these Conditions and Guidelines to be eligible for the rebate.

- Tank Rebate Claim Form. If you have purchased a tank before **30 April 2021**, we encourage you to complete the claim form and return it to the address on the form to ensure your rebate can be paid before the program closes.

Rebates will be available for claim forms received up to **30 April 2021**.

- A Statement by a Supplier Form. This is only required if you do not have an ABN. If you <u>do not</u> have an ABN and the form is not completed, Goulburn-Murray Water is required to withhold 47% of the payment for the Australian Taxation Office. If you need assistance in completing the supplier form, please either contact the Australian Taxation Office on 132866, or your own financial advisor.

# MITIAMO PIPELINE PROJECT Tank Rebate Conditions

The Mitiamo Pipeline Project has established a Tank Rebate Scheme to assist Landowners with the purchase of water tanks connected to the new pipeline. Below outlines the conditions and guidelines that will apply for the Tank Rebate Scheme, to ensure that the scheme is readily understood and easily accessed by Mitiamo Pipeline customers.

## Rebates for the purchase of One Tank per Tapping Point

Goulburn-Murray Water, via the Mitiamo Pipeline Project Team, will provide Landowners a rebate of up to \$1,500 (ex GST) upon proof of purchase for one tank per tapping point.

## **Conditions & Guidelines**

- The Mitiamo Pipeline Project Tank Rebate Scheme is available only to landowners connecting to the new Mitiamo Pipeline ahead of the spring 2021 Irrigation Season.
- Landowners are entitled to claim a rebate of up to \$1,500 (ex GST) for the purchase cost (excluding delivery and installation) of one tank per tapping point.
   If the purchase cost of the tank (excluding delivery and installation) is less than \$1,500 (ex GST), then the rebate will be limited to the purchase cost of the tank (excluding delivery and installation).
- Landowners with more than one tapping point connected to the Mitiamo Pipeline can claim a rebate for each tapping point for which a tank has been purchased.
- Grant payments will be made upon receipt of an appropriately completed claim form and proof of purchase (receipt) by **30 April 2021.**
- Grants paid will have an acquittal condition requiring proof of installation (photograph is acceptable) be provided by **30 June 2021**. Failure to do so may require the grant payment to be returned to GMW.
- Landowners are to arrange their own purchase, delivery and installation of tanks. There is no preferred tank supplier/manufacturer for eligibility in the Tank Rebate Scheme.
- The Landowner Agreement process has provided assistance in determining the size of tanks required at each tapping point. This includes sizing to meet 4 days on-farm supply requirement. There is no constraint on the maximum size tank however the rebate is limited to up to \$1,500 (ex GST) for the cost of one tank per tapping point.
- Tanks are to include approved CFA fire couplings, inlet and outlet at design size, float valve, gate valve and manhole cover (600 mm x 600mm).
- Rebates will be available for claims received by G-MW up to 30 April 2021.
- G-MW will reimburse the GST component applicable to the amount payable
- Rebates to be paid by G-MW within 28 days, preferably via EFT.
- A register of all rebates paid will be maintained.

Upon proper completion of the Tank Rebate Claim form, including provision of proof of purchase (i.e. receipts), Goulburn-Murray Water agrees to reimburse the property owner up to \$1,500 (ex GST) per tapping point for the purchase of water storage tanks for connection to the Mitiamo Pipeline. If the purchased tank has not yet been installed, acquittal of this grant requires proof of installation to be provided by **30 June 2021**.

Upon submission of this Tank Rebate Claim Form, Goulburn-Murray Water will issue a tax invoice on behalf of the Property Owner that reflects the sum paid to the Property Owner. The Property Owner will not issue a further tax invoice in respect of this payment. The Property Owner will meet their GST obligations.
