Main Topics Discussed

Deliverability Risks Report - Joe Banks & Ben Dyer

- Joe explained the deliverability risks pose two types of shortfall (acute & chronic) and both MDBA and the basin states have different responsibilities in managing the risk
- Supply and demand have changed over the past 10/20 years Reduced Barmah Choke capacity
 and water resource from Menindee lakes plus Horticulture crops are increasing and more water for
 irrigation & the environment downstream of Barmah is required
- Menindee supplied 44% of water in summer peak to SA but now that has reduced to 20%
- Increased trade (300GL IVT) to meet pre basin plan recovery demand is contributing to the damage to natural waterways such as the Lower Goulburn river
- Ben Dyer explained the findings of the investigation to the reduced capacity of the Barmah choke which has reduced from 11,500ML/d in 1980 to 10,500ML/d mid 1990s and 9,200ML/d in 2019
- A large volume of sediment gradually moving downstream from Yarrawonga is causing the restriction
- The key findings of the deliverability risks report released in November 2020 summarise the shortfall risks and identify the actions and priorities for government
- Some discussion around the Broken Creek measurement for environmental water and calculation of losses
- Joe advised that Broken creek flows will be part of the Goulburn to Murray trade rule review
- GMW to recheck gate tips on outfall regs along the creek system prior to next meeting

Irrigators Share Distribution - Fabian McCloy & Claire Nihill

- Fabian explained the Irrigators share is the 75GL LTAAY dividend from stage 1 Connections project
- Customers with >0.25 dse will receive approx. 4ml of HRWS & 1.8ml of LRWS and those with <0.25 a cash benefit payment
- Customers will receive the water shares in October 2021 with the allocation for 21/22
- In completing the dividend distribution project work includes quantifying and confirming the water savings from the project and then working through the process of distributing water share to the beneficiaries.
- Customers can check and confirm their delivery share (IAF) by reviewing their 20/21 fixed charges or contacting GMW. Water Shares likely to be distributed against main ABA
- Claire explained the communications timelines for the project to ensure all stakeholders are informed
- An online customer calculator to be made available to assist beneficiaries establish the water shares they will receive from their delivery share holding
- Discussion around existing customer aged debt and eligibility to participate in the water share distribution (working with the legal)

Loss Allowance Review - Andrew Shields

- Provided background on the GMW bulk entitlement and allowances for distribution losses
- Reviews were conducted in 2007 and 2013 but the findings were not implemented
- Original loss allowance is overdue with Connections project wrapping up and GMW / DELWP are collaborating to ensure there are enough losses for the Murray system
- Graphs were provided showing the data and proposed future loss volumes
- A table indicating some impacts around seasonal determinations more water available when allocation is low but slightly less in wet years
- Next steps, finalise technical paper, present to GMW Board and WSC in February
- Previous presentation provided to the committee at the November WSC meeting 2020

Operations Update - Brendan Brooks

- Provided the committee with an update on water delivered for irrigation and environment in both Shepp and MV systems
- Staff completing meter readings for variable charges and have completed approx. 4000 work orders including corrective and preventative maintenance on regs and meters during season
- Desilting and arrowhead spraying on a number of smaller channels by IDS / spray teams
- Successful acrolein injection in the MV 5 main to reduce submerged weed has improved channel performance monitoring channels in case any other treatment is required
- Planning for increased water delivery in autumn with significant water availability
- East team are planning winter maintenance activities and dewatering program to manage weeds and complete capital structure and linear programs

Other Items to Note

- Rabi Maskey provided the committee recent DEDJTR activities reports
 - No new application for Whole Farm Plans opportunity for limited funding
 - Land use mapping in the GMID Stage 2 Survey approx. 400 customers randomly selected with 130 survey's returned. Data to be analysed in March

- The WSC discussed current WSC memberships, how to attract new members, the future of WSC and opportunity of amalgamation Murray Valley and Shepparton
- Amabel Grinter has indicated a transfer across to the Central Goulburn WSC due to recently buying a property with her partner in the CG area.
- Paulette McIntosh will continue on WSC until June or July 2021
- Alan Hendy will participate in Farming Working Group 100th meeting via video conference next week
